Meeting called to order at 7:32pm By Paul D'Andrea.

Reports of the Officers:

- 1. Susan Butler asked for a motion to accept the minutes of the October meeting as published in the Parll newsletter. Motion was made and second. Accepted as published.
- 2. Treasurer Manuel Hevia reported on the homes in arrears of the quarterly assessments. There are 5 homes on the top of the list, 2 have made payment arrangements and will get caught up as they make current payments also. Three are due to deceased owners and foreclosure. If there is a reverse mortgage the bank is in no hurry to claim. The one foreclosure is going to court and we may not have an answer on that until 2020 in a few months... There are 7 homes that are more than 1 quarter overdue and they will receive letters and there are another 7 that are only past due this last quarter.
- 3. Social Bob McClellan Lightening bingo is back, we are playing 2 Thursdays per month starting at 7:15pm. There is a \$1.00 buy-in which goes to the super jackpot each ½ hour of play, if any ½ hour is not won, it will roll over to add to next game. In 2 weeks. And don't forget, everyone goes home a winner, if you do not win any games; the final pot is split amongst all the non-winners. Bingo is open to non-residents as well as residents, so invite everyone.

NEW BUSINESS:

- Volunteers are needed for the Fine Committee, these volunteers cannot be Board members and they will not determine violations.
 They will receive the names of violations that have run the course of time for remedy and determine if there will be a fine as outlined in our bylaws. These recommendations are then passed on to the accountant and attorney for collection.
- Speeding- it is a huge issue for our community, especially on the longer streets where there is room to gain speed. It is hazardous
 and we would like to do something about it. We are looking into Speed humps (not bumps) in the middle of the long stretches to
 slow drivers down. Our Manager is looking into the city requirements and what has to occur to get the humps. And how can we
 get the city to pay for it.
- 3. Car stickers the first step in resolving the parking challenges that we all face on a daily basis, is to identify our residents who are parking and the people who are parking that do not belong on our streets. We are looking into having each home register their cars and keeping a resident sticker in the window. The stickers can be numbered so it cannot be moved from car to car. Each home will start with two stickers each, (if they have 2 cars registered in their names) and any additional cars or residents will need to come in to show proof of residency. We need to start identifying the residents we have that have moved in without screening. The next step will be to enforce parking overnight for residents only. Renting rooms is illegal in our community, and it puts the homeowner at risk of losing their homestead exemption on taxes. If rooms are being rented, it can be why we have too many cars on the roads. There will be a solution to overnight guests, so they will not be towed etc... to be determined
- 4. Parking is a challenge the screening committee is being more aggressive with informing new owners of the regulations on parking on the streets, and actually asking how many cars the new owners have, and asking where the excess cars intend to park. The new chairperson of the screening committee is Sharon Hevia.
- 5. Think about where you are parking and be considerate of your neighbors. There are no reserved parking spots and anyone can park on any part of the street legally, remember only can park on one side of the street, so no one owns the parking in front of your home. It is okay to park in the clubhouse parking lot, just leave a note in the window with the owners name and address and phone number in case of emergency.
- 6. The pool we are trying to get certified for nighttime open of the pool, from dawn to 10:00 PM. The lighting needs to be upgraded and inspections need to be passed before we can do that.
- 7. We need more participation from everyone for events, it is our community and it is our residents that make our community active and happy. Please participate in using the clubhouse, attending social events and meetings etc....

QUESTIONS FROM THE FLOOR

- Property management it was reported that Management is slow to respond or non-responsive to calls and request. If you have
 any concerns that are not being addressed in a timely manner by Management, Please contact Paul directly, so he can address it
 with Management. Please attempt to contact management first as it is what we are paying them for. Do not go straight to Paul.
- 2. Parking illegally along the double center line close the corners. It is dangerous and it is difficult to turn some our corners without hitting a car. We are looking into what we can do, we have to contact the city because it is their street, not ours. We may have more information at next meeting.
- 3. Washing the shuffleboards at a previous meeting, it was discussed that we may wash the shuffleboards and bring them back to life. What plans are in the works? Again, we need volunteers and maybe we can make an event out of reopening. Will keep everyone posted.

Motion was made to adjourn the meeting at 8:198pm. Was seconded and all agreed. Minutes of this meeting were recorded by Susan Butler – Secretary
